APPOINTMENT OF EXECUTIVE DIRECTOR

The board (the “**Board**”) of directors (the “**Directors**”) of Basetrophy Group Holdings Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) hereby announces that Mr. Han Xu (“**Mr. Han**”) has been appointed as an executive Director of the Company with effect from 2 October 2025.

Biographical details of Mr. Han

Mr. Han, aged 41, graduated from Heilongjiang University in 2007 with a bachelor’s degree in tourism management. He is currently serving as a director and general manager of Guiyang Versailles Hotel Management Company Limited* (貴陽凡爾賽酒店管理有限公司). Besides, he has over 10 years of experience in tourism profession. He was an executive director of Silkwave Inc (a company listed on the Main Board of the Stock Exchange, stock code: 0471) from 18 March 2024 to 8 May 2024.

The Company has entered into a service contract with Mr. Han for a term of three year with effect from 2 October 2025 (the “**Service Contract**”). Mr. Han will hold the office until the forthcoming annual general meeting of the Company and be eligible for re-election at that meeting pursuant to the articles of association of the Company. The emolument of Mr. Han is HK\$180,000 per annum, which was determined by the Board based on the recommendation of the Remuneration Committee having regard to his background, his responsibilities within the Group, the financial position of the Company and the prevailing market conditions.

Save as disclosed above and as at the date of this announcement, (i) Mr. Han did not hold any directorship in any public companies the securities of which are listed on any securities market in Hong Kong or overseas in the past three years; (ii) Mr. Han does not have any interests in the shares of the Company within the meaning of Part XV of the SFO; (iii) Mr. Han does not hold other positions with the Company or any subsidiaries of the Company; (iv) Mr. Han does not have any relationship with any directors, senior management, substantial shareholders or controlling shareholders (the “**Shareholders**”) of the Company; and (v) there is no other information relating to Mr. Han that is required to be disclosed pursuant to Rule 17.50 (2) of the GEM Listing Rules nor are there other matters relating to Mr. Han that need to be brought to the attention of the Shareholders.

The Board would like to take this opportunity to welcome Mr. Han to the Board.
